The Trustee of the ICI Pension Fund is keen to ensure that members remain in contact with the Fund's administrators, Willis Towers Watson. Occasionally the Trustee has lost touch with some of its pensioner members and these are often our most vulnerable pensioners who have limited interaction with the outside world, such as the very elderly or infirm.

We have a number of pensions, which as a last resort, we have suspended paying because, despite all efforts to trace them, we have lost contact. We want to reduce the number of people we lose touch with in the future and so the Trustee is asking pensioner members to provide alternative contact details of someone that you trust who we could contact if we are having difficulty in getting a response from you.

DATA PROTECTION

The Trustee (ICI Pensions Trustee Limited), whose registered office is at 3rd Floor, 38 Lombard Street, London EC3V 9BS), is the “data controller” in respect of personal data processing for the administration of the Fund.

In processing your personal data, the Trustee may:

- process your sensitive personal data such as information regarding your health records;
- pass on personal data to third parties which may include the Fund’s sponsoring employer, professional advisers, administrator, insurance companies, counterparties to Fund investments, as may be necessary or desirable for the operation of the Fund; and
- retain your personal data for legitimate business reasons or to comply with applicable laws.

In the event that your personal data is sent outside the EEA, the Trustee will still process your personal data in accordance with the applicable UK and EU data protection laws, and will take reasonable steps to ensure that your personal data is handled securely and in accordance with the data protection policy at www.icipensionfund.org.uk.

In certain circumstances, your personal data may be passed to the Fund actuary and Willis Towers Watson and, where this is the case, the Fund actuary and/or Willis Towers Watson may also be data controllers of your data.
